### Meeting Called to Order/Roll Call/Declaration of Quorum/Flag Salute/Invocation

All items on this agenda, including but not limited to any agenda item concerning the adoption of any ordinance, resolution, contract, agreement, or any other item of business, are subject to **amendment**, including additions and/or deletions. This rule will apply to every individual agenda item without exception, and without providing this same **amendment** language with respect to each individual agenda item. Such amendments should be rationally related to the topic of the agenda item, or the governing body will be advised to continue the item.

The governing body may adopt, approve, ratify, deny, defer, recommend, amend, strike, or continue any agenda item. When more information is needed to act on an item, the governing body may refer the matter to its Mayor, Acting Mayor or Presiding Officer, staff, attorney or to the recommending board, commission, or committee.

All Agenda Items Are for Discussion and Whatever Further Action the City Council Deem Necessary or Advisable to Discharge Their Constitutional and Statutory Powers of Government.

Note: Only items listed on the agenda can be discussed between the commentor and the governing body members. If there is any agenda item that any person wishes to address, such person shall sign the signup sheet listing the item such person would like to discuss. The Mayor, Acting Mayor or Presiding Officer, at the beginning of the meeting shall ask the City Clerk whether anyone signed the signup sheet and concerning what specific agenda item. When called the person desiring to speak should raise their hand to be recognized by the Mayor, Acting Mayor or other Presiding Officer. Such a person should stand before the podium and shall address their remarks to that specific agenda item. A maximum three (3) minute address by such person may be provided.

For commentors on items not on the agenda, such persons shall be provided a maximum of three (3) minutes, but no discussion should occur between such commentor and the governing body. If discussion is desired, the item should be directed to be placed on the next regular or special agenda. The Mayor, Acting Mayor or Presiding Officer may provide additional time. This procedure is to ensure that no violation of the Oklahoma Open Meeting Act occurs.

- 9. Consider Items Pertaining to the Waynoka Chamber of Commerce:
- A. Consider Approval of Contract with the Waynoka Chamber of Commerce for Tourism Development.

**Background:** Since July 1, 2016, the Waynoka Chamber of Commerce has been assisting the City in the public purpose of tourism development and have been monthly paid through hotel tax funds. This rate of pay has not increased in nine years. It is recommended to increase their monthly compensation by \$300.00 per month. A copy of a proposed contract is enclosed, the term of which would be through June 30, 2026, provided the appropriation is included as a part of the FY2025-2026 General Fund Budget. Subsequent contracts require the approval of both governing boards.

**Background:** The annual Snake Hunt Event occurs next month and the Saddle Club requests the opportunity to discuss the event. The City Council can direct action required due to Snake Hunt pertaining to street closures, public property use, refuse, vendors or other issues as are associated with this event.

11. Consider Approval of Ordinance No. 2025-\_\_\_of the City of Waynoka, Oklahoma, Amending Chapter 2, Section 2-407 of the Waynoka Municipal Code 2024, Providing for the Annual Salary for Mayor of the City; Providing Further that Such Salary shall constitute Full Compensation for all Duties Performed as Trust Manager of the Waynoka Utilities Authority; Providing For Repealer; Providing for the Annual Salary of Councilmembers; Providing for Savings Clause; Providing for Severability; Providing for Codification; Providing for Effective Date; and Declaring an Emergency.

**Background:** An ordinance was adopted ten years ago setting a \$36,000.00 annual salary, health insurance and 40 hour a week employment for the Mayor. It was repealed at the next regular meeting. The Mayor's work is voluminous, detailed and exhausting and the cost of a mayor's assistant, or City Administrator, as Waynoka has had in the past, under today's market would range from \$70,000.00 to \$90,000.00.

The current \$3600.00 a year salary hardly pays for the gasoline and other expenses required for the work, which are normally not charged or paid either.

Article 23, Section 10 of the Oklahoma Constitution states as follows:

Change of salary during term - Extension of term - Continuance until qualification of successor.

Except wherein otherwise provided in this Constitution, in no case shall the salary or emoluments of any public official be changed after his election or appointment, or during his term of office, unless by operation of law enacted prior to such election or appointment; nor shall the term of any public official be extended beyond the period for which he was elected or appointed: Provided, That all officers within this State shall continue to perform the duties of their offices until their successors shall be duly qualified.

There are no cases which define this constitutional provision. But it appears that the compensation could be *legally* changed after the filing period and before the election if that was desired.

The City Council may decide to set a different amount of salary for the Mayor or take no action, all at the City Council's discretion. The opportunity to amend the salary for the Council members is also provided. This ordinance is appropriately considered before every general municipal election to determine whether an amendment is warranted and was not suggested by the Acting Mayor.

This ordinance continued until this meeting at the City Council's direction.

## 13. Consider Approval of Contract for Residential Inspection Services with Henry Code Compliance LLC.

**Background:** The City Attorney misquoted the fee. \$250.00 to act as community development director and \$75.00 per hour for the permitting work and inspection, if directed. He will be present to speak to the issues and any limitations desired to be placed on total costs. A new ordinance providing for increased costs is being developed and will be submitted at the next meeting. The Council requested that this item be continued until this meeting.

Background: Section 12-101 of the Waynoka Municipal Code 2024 provides in pertinent part:

"There is hereby created a planning commission of the City. Said commission shall be composed of five (5) members, all ofwhom shall be residents of the city, nominated by the mayor and confirmed by the city council."

There is one vacancy on the Commission. Should the Mayor have a nomination, the governing body should consider their appointment.

**Recommendation:** If a nomination occurs, consider appointment of resident to the Waynoka Planning Commission.

15. Consider authorizing the Mayor to execute an amendment to the professional services agreement with RL Shears providing certain amendments to the 3<sup>rd</sup> phase of the streetscape project and make payment in an amount not to exceed \$10,000.00 or have the state cover the cost with a probable and substantial delay or proceed without change.

**Background:** Former Mayor Bradford suggested certain amendments to the 3<sup>rd</sup> phase of the streetscape project which will require additional engineering. The cost is estimated at \$10,000.00. Would the City Council prefer to authorize the Mayor to execute an amendment to the professional services agreement with RL Shears to provide for the changes to the 3<sup>rd</sup> phase of the streetscape project and make payment in an amount not to exceed \$10,000.00 or have the state cover the cost with a probable and substantial delay or proceed without change. Will request that Former Mayor Bradford explain the changes by email or in person.
